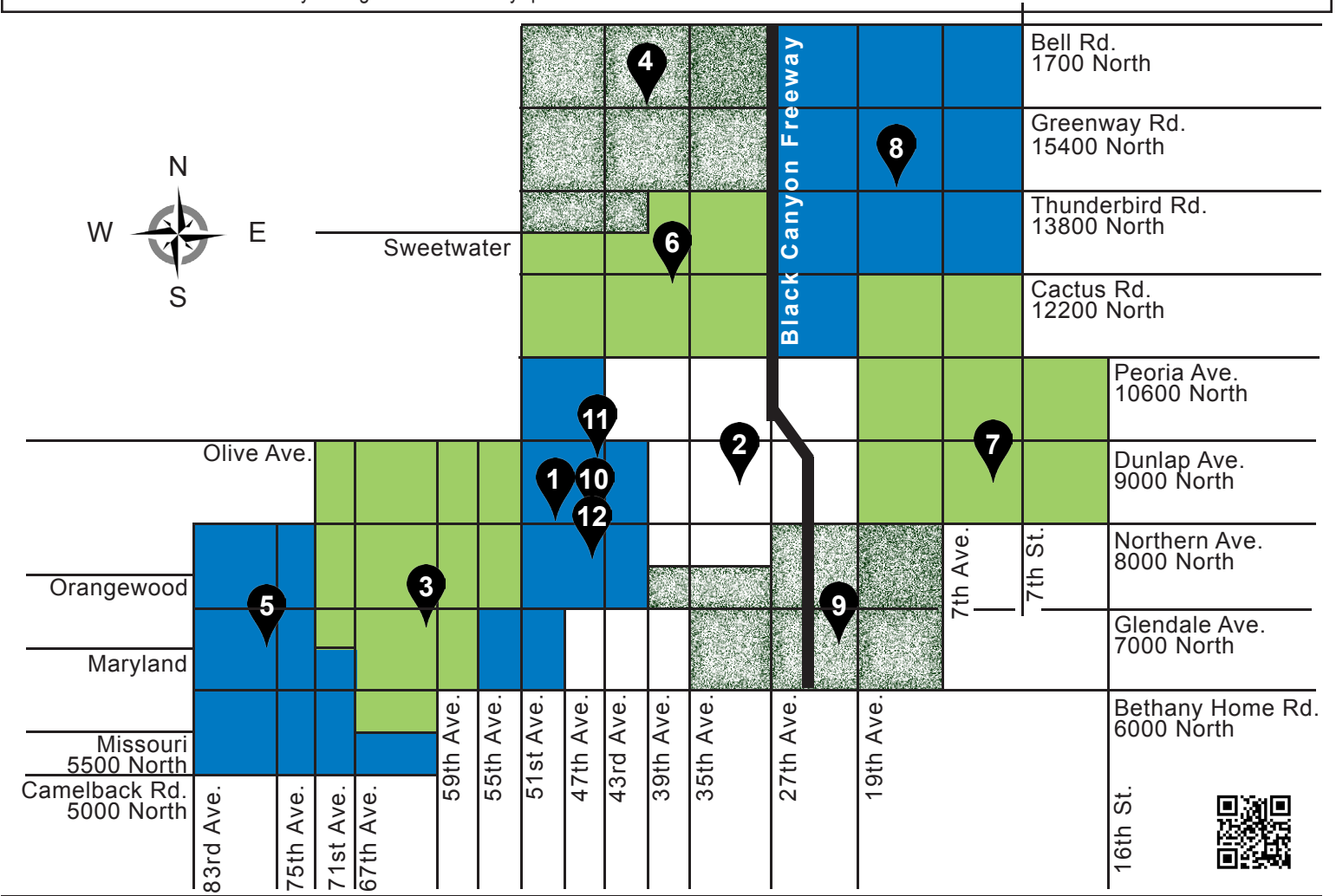


# GUHSD Attendance Area Map
